for friendly communication and cooperation with parents

BASIC REQUIREMENTS

All are mandatory. The facility must meet them in at least one of the following ways.

We meet these criteria:

- The parents can get into the school without problems, including in the afternoon.**
 - There is a visibly marked door bell at the entrance door. The authorized person lets the parents into the school after they ring the bell.
 - There is a visible telephone number at the entrance door which the parent should call to be let into the school by the authorized person.
- Contact information of all teachers and the school management is available to the parents.**
 - At the beginning of the school year, the parents receive a printed current list with contact information, mobile phone number or email address of the class teacher.
 - The school has an updated website containing the names of all teachers and the school management. The website includes contact information (email address, telephone number) of the school management and the telephonist, ideally of all employees of the school.
 - The parents have the opportunity to look up current contact information in the school's information system.
- The parents are informed about what is happening in the school and when.**
 - At the beginning of the school year, the parents will receive printed information about when there will be school holidays, when class meetings, open days and other major events for the parents and pupils of the school take place.
 - This information is always available on the school's website; the school continuously updates it.
 - This information is available in the school's information system.
- Communication between the school (teacher) and the parents**
 - We communicate with the parents in a partnership manner (mandatory).
 - We guarantee to the parents that during class meetings we do not discuss the school results and behaviour of their child in front of the other parents (mandatory).
- We have informed the parents of children who use the services provided by our school about the intention to apply for the Parents Welcome label.**

The parents have been acquainted with the information provided in the certification form, agree with this information and are willing to confirm it.
- We organize school events for parents on days and at hours that will allow the parents to really attend them.**
- The information board about the Parents Welcome label is visibly located at the entrance to the school.**

OPTIONAL REQUIREMENTS

The facility must meet at least two other requirements that it chooses from the optional ones.

We meet these criteria:

- We make sure that the school enrolment is a pleasant social event for the parents and their children. In doing this, we think about the needs of the children and parents.**
 - Our teachers offer office hours for the pupils and parents.**
 - In addition to the pupil's record book and class meetings, we offer the parents also another way how to inform them regularly about their child's results.**
 - In addition to collective class meetings, we also organize three-way teacher-child-parent consultations.**
 - We resolve conflict situations in the school in a manner ensuring that everyone involved, including the parents and the child/children, can participate in the resolution.**
 - We make the school education programme and other school documents available on the school's website.**
 - We offer the parents consultations with our school psychologist / educational counsellor.**
 - The parents have the opportunity to influence the way their children eat in school.**
 - The parents of our pupils and those interested in our school have the opportunity to attend classes by prior arrangement.**
 - We invite the parents to attend classes, to participate in working together with their child.**
 - We organize school events where the parents and other family members can work with the children and meet the teachers.**
 - We can recommend to the parents the services of an external expert – a child psychologist, speech therapist, mediator, etc.**
 - We provide the parents with a space for an open discussion about the school on the website.**
 - An independent parent organization with its own legal personality operates in our school.**
 - The parents have the opportunity to use the premises of the school for their own events by prior arrangement.**
 - We organize educational seminars for the parents on the topic of upbringing and education.**
 - We organize "curricular afternoons" where we explain to the parents what, how and why we teach in our school.**
